## *Legal Fee Schedule – Independent Medical Exam, Deposition, Narrative Report*

---

### Independent Medical Examination - I.M.E. / D.M.E

- \$1,750 (fee is for the exam, completed report, and record review of the first 200 pages)
- Full payment and medical records are required 10 days prior to date of service
- No show/Failure to cancel fee: \$350 (per occurrence)
- Returned checks (NSF fee): \$50.00 per check
- **Note:** Reports are normally completed within 10 calendar days. An additional \$300.00 will be charged for “rush requests” (turnaround time of 1-2 business days)

### Review of Records for IME

- For review of records in excess of the 200 pages of material: \$100 for every 25 pages

### Medical File Review

- Medical file review rate for up to 200 pages: \$2,800
  - If the file exceeds 200 pages, a retainer of \$1,750 is required prior to review
- Report Preparation fee: \$350 per hour and must be received prior to release of report

### Deposition within Sussex County, DE and in-person/Telephone

- For the first hour: \$1,750
- After the first hour: \$500 for every half hour
- Video Deposition: \$2,500
- Payment must be received within 10 business days of the scheduled appointment date

### Refund Policy for Deposition/IME/Narrative Report

- More than 10 business days: 100% refund with \$100 Cancellation Fee
- 6-10 business days: 50% refund with \$100 Cancellation Fee
- 5 or less business days: NO REFUND

### Deposition/Court Testimony outside of Sussex County, DE and in-person

- For the day: \$5,500 per day

- Travel (out of Sussex County): \$550 per hour plus expenses
- Payment must be received within 10 days of the scheduled appointment date.
